DECLARES UNDER ITS RESPONSIBILITY:**

- 1) **To be aware of the containment measures provided** for art. of the Decree of the President of the Council of Ministers dated 11 March 2020, for Article 1 of the Decree of the President of the Council of Ministers dated 22 March 2020 and for Article 1 of Decree of the Minister of Health dated 20 March 2020 concerning **restrictions on the possibility of personal movement within the whole national territory**;
- 2) To be aware of measures established with **Interministerial Decree of Infrastructure and Transport – Healthcare nr. 120 dated 17 March 2020.**
- 3) **To be not to the quarantine measure and not to have tested positive for the COVID-19 virus** as per Article 1, paragraph 1, letter c), of DCPM dated 8 March 2020.
- 4) **To be aware of the penalties provided for by the combined provisions of art.3, paragraph 4, of D.L. dated 23 February 2020, n.6 and art. 4 paragraph 2 of the DCPM dated 8 March 2020 in the event of non-compliance with the above mentioned containment measures** (art. 650 of the Italian Criminal Code unless the fact does not constitute a more serious crime);
